Subscriptions/Annual Donations & Gift Aid 2017/2018

Annual Subscriptions (or annual donations as the charity would wish to call them for tax purposes) are set each year at committee in May or June for the following season.

As the club is run on entirely voluntary basis it relies on these annual funds to survive. The payments you make to the club are used toward providing equipment for the children, such as mini, junior and senior size goals, nets, training cones, bibs, poles, trophies, first aid equipment, and site maintenance such as line marking, grass cutting, slitting the pitches, and seed, sand and topsoil. The contributions also go on league membership and county FA affiliation, as well as training all our coaches to at least FA Level 1 or 2 standard and attending age appropriate courses as well as first aid training. The club also pays for CRB (DBS) checking all involved with the club, referee fees, league fines and any necessary council pitch hire for weekend matches for our teams when Seaview is unplayable for many months over winter. Your payments also cover our insurance costs. **Please note it does not cover the cost of the kit which is paid for by sponsors and remains the property of the club should your child decide to leave.**

The coaches, team managers, committee members and trustees are all unpaid volunteers.

This year Under 6s parents/carers are asked to donate £2.50 per session that their child attends. There is no further annual subscription required.

The Annual Subscription or Donation for **all other age groups is £190.00**

All training facilities have been booked for the season. Your coach will advise you of your specific training locations and times.

For those who choose to pay by standing order or by a one off payment at the very start of the season we are offering a discount of £20.00 on the figure quoted above meaning the annual donation is £170.00.

Therefore Annual Subscriptions or Donations and training may be paid in one of 3 ways:

- 1) One single payment to be received before 31st October 2017 for £170.00 by cheque or cash. Please make cheques payable to Tankerton F.C.
- 2) Collected over the course of the year by 10 monthly payments of £17.00 by standing order (September to June inclusive).
- 3) Two payments for the season, one of £95.00 to be received before 31st October 2017 and a second payment of £95.00 in the new year to be received before 28th February 2018 by cheque or cash. Please make cheques payable to Tankerton F.C.

A 50% reduction is available to any subsequent siblings. Please pay the full amount for your eldest child and the reduced amount for any other children at the club. If paying by standing order please set up a separate payment for each child.
